FINANCIAL AGREEMENT

I/We understand that the financial decisions and operation of St. Anthony School occurs through the payment of this financial agreement.

1. Parents have an obligation to fulfill their financial agreement of tuition, fees, fundraising requirements and volunteer hour requirements.
2. Reevaluation: Should financial problems occur and promised payments cannot be made according to the payment schedule, families are to call the school. The school will help you set up a new payment plan that will help you to pay your financial agreement before June 1st of the current academic year. Graduating 8th graders must have all tuition and fees paid by May 15th.
3. All fundraising monies are for school operations and are not credited to personal tuition, fee accounts, or hour accounts.

Tuition Commitment

Option 1: Pay in full \$5,700 and attend five school events: Back to School Night, Parent Conferences, Christmas Program, First Reconciliation Parent Meeting, and First Eucharist Parent Meeting.

Option 2: A discounted tuition if enrolled in eScrip, participating in school's Scrip program, PTO fundraising events, and parent service hours.

Eleven monthly payments in the following amounts beginning July 10, 2010 and ending May 10, 2011:

Tuition is due the tenth of every month beginning July 10, 2010.

Registration Fee: \$250 x # of students due June 1, 2010 or spread over the first four month of the contract.

Parent Service Hours

1. Family requirements:
 - a. 35 volunteer hours or pay \$525. Hours not worked will be billed at the rate of \$15 per hour.
 - b. Each family is required to volunteer 3 of their 35 hours during the school fiesta.
2. Fundraising Commitment:
 - a. Earn \$400 minimum net profit through fundraising or pay \$400.
 - b. Sell \$100 per child of Fiesta Drawing Tickets.

Please note:

- All tuition payments are payable to Smart Tuition.
- After the first day of the month, that month's full tuition is non-refundable.
- The full value of the financial agreement is non-refundable.
- There will be \$50 charge for a returned check for non-sufficient funds and a \$50 charge if turned over to a collection agency.
- All fees are non-refundable.
